



# **NON-DISCLOSURE AGREEMENT**

#### 1. The Parties:

## 3. Recognition of a Compelling Need For Confidentiality:

EasyTech Solutions acknowledges that The Client has a compelling need to maintain confidentiality and recognizes that the discussions or agreements will place both parties in a position of trust regarding access to confidential information.

#### 4. Consideration:

As a precondition for discussions, employment, or contract with The Client, *EasyTech Solutions* agrees to uphold confidentiality as detailed in this agreement.

#### 5. Commitments of Both Parties:

The Client and EasyTech Solutions mutually agree to:

- Work in good faith to explore business opportunities as defined within this Agreement.

#### 6. **Notification of Requests:**

## 8. Purpose of Exchange:

#### 9. Definition of Confidential Information:

"Confidential Information" includes but is not limited to trade secrets, strategies, technical data, business plans, client lists, pricing, and other proprietary information, whether written, oral, or electronic, as disclosed by either party.

## 10. Non-Disclosure Obligations:

The Receiving Party agrees not to disclose the Confidential Information to any third party or use it for purposes outside the scope of this agreement without prior written consent from the Disclosing Party.

## 11. Liability for Affiliates and Representatives:

Both parties are responsible for ensuring their representatives, affiliates, and employees adhere to this agreement.

#### 12. Return or Destruction of Information:

Upon request, all confidential materials must be returned or destroyed, with one archival copy retained only for determining compliance with obligations.

### 13. Dispute Resolution:

Any disputes arising out of this agreement shall be resolved amicably or through arbitration under the Arbitration Act, with proceedings conducted in English/Hindi in Basti, UP, India.

#### 14. Non-Solicitation Clause:

Neither party will solicit or hire employees, contractors, or partners of the other party during the term of this agreement and for five (5) years thereafter.
